RFQS DESCRIPTION: Lake Havasu City is interested in receiving Statements of Qualifications (SOQs) from qualified Construction Managers at Risk (CMAR) to provide pre-construction services and construction services for the Second Bridge and Roadway Construction Project.

Statements of Qualifications submitted must address, at a minimum, all issues brought forth in this Request for Statements of Qualifications (RFSQ). This project Design and Construction is funded by the State of Arizona Legislative Funding. The Second Bridge and Roadway network have been determined to be needed for Emergency Evacuation and Emergency Access to serve the isolated Island Community should the London Bridge and utilities within the superstructure be deemed unpassable or unusable. The Second Bridge will provide a secondary alternate route.

There is not an expressed or implied obligation for Lake Havasu City to reimburse responding firms for any expenses incurred in preparing SOQs in response to this request.
