Tent Permit Application

A Fire Department Tent Permit is required if erecting an air-supported temporary membrane structure or a tent with an area in excess of 400 square feet unless an exception below applies. A \$100 permit fee will be charged for a plan check and inspection.

Exceptions:

- 1. Tents used exclusively for recreational camping purposes.
2. Tents open on all sides and comply with all of the following:
2.1. Individual tents do not exceed 700 square feet; and
2.2. The aggregate area of multiple tents placed side by side without a fire break clearance of 12 feet does not exceed 700 square feet total; and
2.3. A minimum clearance of 12 feet to all structures and other tents.

Permit process and time frame: In order to process your application or request for service within 72 hours from the date of submittal, all requested information and attachments must be provided.
