6.1 Improving Directional Placard for Island Walk/Bike Path

Committee member Jeff Smolek is proposing to get directional placards sprayed painted on bike/walking path on the island. Smolek would like to adopt the island path into the trail plan. A discussion took place amongst the committee members regarding safety concerns and maintenance of the path.

Committee member Bill Bryan motioned to bring Improving Directional Placards for the Island Walk/Bike Path item to the Parks and Recreation Board for their recommendation to finish maintenance activity of painted stenciled directional signs on the path; seconded by Jim Rosensweet and unanimously carried by the committee.

### 6.3 Piccadilly Point Trail Spur - Update

Chairman, Mary Van Rooy reported Dub Campbell has volunteered to use his equipment, and manpower to grade a 12 foot wide path compacted with aggregate base compound to construct Piccadilly Point Trail. Director, Greg Froslic, Dub Campbell and a few members walked the site. Froslic stated from the City's prospective the trail is part of the plan development extension of the Rotary Park network which is concrete so the City's desire is to one day have that concrete. Froslic stated we can accommodate this aggregate base and staff has prepared a map that we can use as a guide. Chairman VanRooy submitted a letter explaining the process and it has been discussed with the City Manager and we have support to build this trail. Froslic will schedule a meeting with our Risk Management Division and the City Attorney to find out what process we need to follow to get Dub's men out there and still protect the City.
